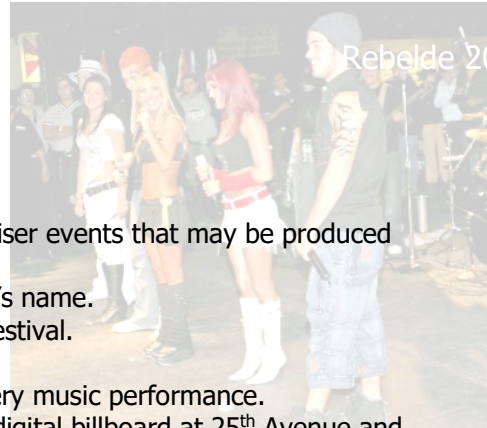

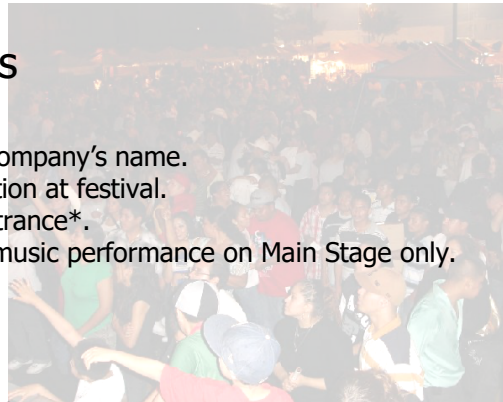

HispanoFest is compiled of local business owners, Village of Melrose Park employees, community volunteers and the continued support of the Mayor of Melrose Park Ronald Serpico. HispanoFest is also a non-for-profit 501(c)(3) of the Internal Revenue Code and also classified as a public charity under sections 509(a)(1) and 170(b)(1)(A)(vi).

Mission: HispanoFest promotes the advancement to the Hispanic Community through educational and leadership development.

Festival: Because HispanoFest is an educational based organization; the festival is a family oriented atmosphere. The festival brings together Latin foods (45 food exhibitors), arts and crafts (45 booths), entertainment and a children's carnival all in one location.

How do we do it? HispanoFest is possible because of ongoing fundraising of our major sponsors, our sales of booths and the vendor commitment. HispanoFest also accomplishes their goals by fundraising through the residents and business owners in the community. This major event allows the committee to award scholarships to local Hispanic students that live in the surrounding suburbs and are currently attending a college, university, or a trade school. Over the past 32 years HispanoFest has awarded hundreds of scholarships.

Scholarships: Applicants must be of Hispanic origin, reside in local suburbs, and be a full-time or part time student at a college, university or trade school. Students must complete a 600-900 word essay explaining their plans for career and future. Recipients must maintain 3.0 GPA, and volunteer for the three days at the Hispanofest festival. Each student receives a \$1,500.00 scholarship (if enrolled in a university) or \$750.00 (if enrolled in a 2 year community college or trade school) scholarship or if enrolled in a university part time they receive \$750.00 and if it's a 2 year community college or trade school \$325.00 which is paid directly to the school of their choice.

Location: HispanoFest is taking place for the 11th year in a row on the clean beautiful grounds of the Village of Melrose Park Civic Center, 1000 N. 25th Avenue, Melrose Park IL 60160.

Parade: The parade commences at 11:00am gathering at 10th Avenue and Main Street in Melrose Park, IL, it proceeds up Lake street and ends at 25th Avenue in front of the Civic Center of Melrose Park.

Security: The Melrose Park Police Department provides the festival with adequate security, patrolling the grounds of the festivities and the surrounding area.

Entertainment: The HispanoFest entertainment committee works hard to bring all different types of Latin music, dancers and performers to the festival. There are two stages performing simultaneously. The committee works with radio and television promoters to bring internationally known artist like: Traileros Del Norte, Brazeros musical, RBD Rebelde, Anais, Pateles Verdes, Los Cadetes de Linares, Grupo El Tiempo, Conjunto Miramar, Nueva Era and Banda Radar. Each stage is equipped with its own dance floor.

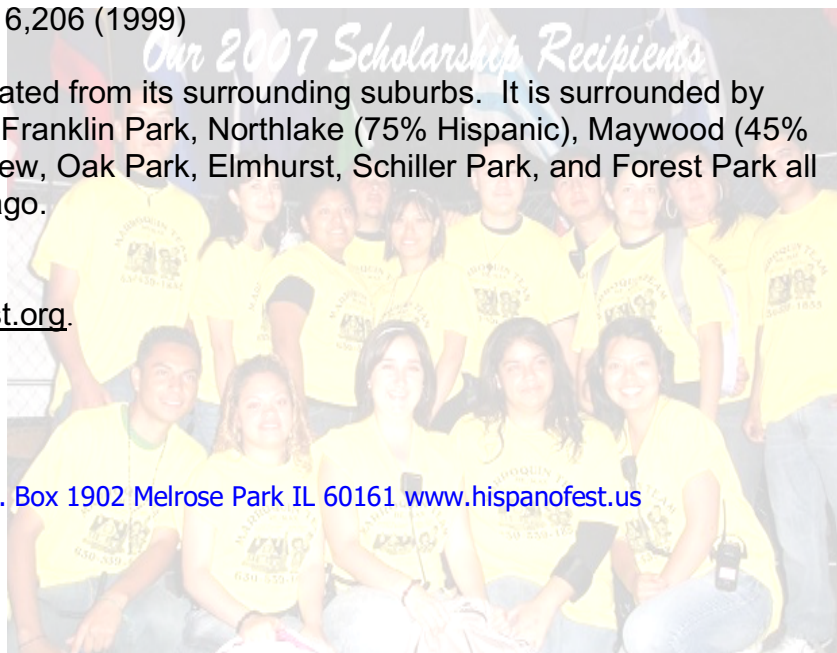
